The Chapter is looking for members interested in furthering their professional development. The Chapter offers the opportunity to attend the CMAA World Conference, Business Management Institutes, CMAA Communication Summits, or Regional Conferences aligned with the CMAA. The Scholarship must be used by the recipient within 18 months of award. The Nielson/Hollister Scholarship carries a value of \$3000. The Susan Rogers Legacy Scholarship (in Partnership with Endicott Coffee) carries a value of \$1500. Funds awarded can be applied to conference registration along with reasonable expenses for airfare, lodging, and meals. The scholarship will be granted based on the recommendation of the Scholarship Committee and approval by the Board of Directors of the Evergreen Chapter of CMAA.

Who Should Apply? Any manager with upstanding membership in the Club Management Association of America can apply. The purpose of the scholarship is to provide the opportunity for a manager to further their educational process to better their Club and their professional development.

Application Requirements

1. Candidate must complete the Scholarship application form.
2. Candidate must submit an essay addressing the following:
 - a) A member of CMAA 5+ years:
 - i. What is your individual philosophy towards developing future leaders within the Club Industry?
 - ii. Describe how mentoring has influenced your career or describe your leadership philosophy.
 - iii. How would attending a Business Management Institute Benefit your professional development and your Club?
 - b) A member of CMAA for less than five years:
 - i. . Describe your career objectives & goals.
 - ii. How would the educational opportunity advance your professional development.
 - iii. Detail how this specific continued education can positively impact your Club.
 - iv. List significant achievements and/or accomplishments in your position.
3. Attach a copy of your current resume to your application.
4. Attach two letters of recommendation to your application.
 - a) One letter of recommendation from your current General Manager
If you are currently a General Manager/COO, provide a letter of recommendation from a Certified Club Manager or Certified Club Executive colleague in the region.
 - b) One Letter from the following criteria – Director from your Board of Directors, a fellow member of the Evergreen Chapter of CMAA, An Executive Member of the Management staff at your Club, or former General Manager.

Applications are due to Jordan@evergreencmaa.org by September 15th, 2023. The scholarship committee will review all applications and award two scholarships to candidates that fulfill the criteria and exude a level of excellence and desire to further their career in the private club industry. Scholarships will be awarded at the Annual Chapter Celebration on November 9th at Glendale Country Club.
